## **YOUTH CAMP ORDINANCE FOR RAMSEY COUNTY**

"The County Board of Ramsey County ordains"

### **1.00 - PURPOSE AND AUTHORITY**

The purpose of this ordinance is to establish standards to protect and promote the health, safety and the general welfare of the people of Ramsey County pursuant to the authority granted to Ramsey County by Minnesota Statutes Sections 375.51 through 375.55 and 145A.05, Subd. 8, and the Delegation Agreement between the Minnesota Department of Health and Ramsey County executed pursuant to Minnesota Statutes, Section 145A.07.

This ordinance establishes minimum standards for children's camps which shall supplement existing applicable laws and codes pertaining to children's camps. Whenever this ordinance conflicts with other applicable laws, regulations, and ordinances, the most restrictive shall prevail.

### **2.00 - SCOPE**

This ordinance shall be applicable to all children's camps as defined in Minnesota Statutes Sections 144.71 through 144.76 which are located in Ramsey County, Minnesota.

### **3.00 - GENERAL PROVISIONS**

**3.01** Administrative Procedures. All of the provisions of the Ramsey County Administrative Ordinance shall apply as if fully set forth herein.

**3.02** Administration. This ordinance shall be administered by the Ramsey County Department of Public Health. The term "Department", where used in this ordinance and the Ramsey County Administrative Ordinance, shall mean the Ramsey County Department of Public Health.

**3.03** Definitions. Definitions of words, phrases, and terms used in this ordinance shall be those set forth in Minnesota Statutes Section 144.71 and the Ramsey County Administrative Ordinance.

### **4.00 - STANDARDS FOR HEALTH, SAFETY, AND NUISANCE PREVENTION**

**4.01** Standards Adopted. Minnesota Rules Parts 4630.2300 through 4630.4700 in effect on October 1, 1992, and any future revisions thereof are hereby adopted by reference and made a part of this ordinance.

**4.02** Standards Amended. The above adopted rules are hereby amended that whenever the term "commissioner of health" appears in these adopted rules, it shall be held to mean the "Department" except in Minnesota Rules Parts 4630.3100 through 4630.3700 where it shall remain unchanged.

### **5.00 - EFFECTIVE DATE**

This ordinance shall be effective upon passage by the Ramsey County Board of Commissioners.
