WHEREAS, On June 29, 1993, Ramsey County Board Commissioners approved, pursuant to the provisions of the Ramsey County Home Rule Charter, a Salary Ordinance for calendar year 1994 which provided for no salary increase for the Ramsey County Board of Commissioners for calendar year 1994 over the annual salary rates for calendar years 1991, 1992 and 1993; and

WHEREAS, The Salary Ordinance approved by the Board of Commissioners for calendar year 1994 states that the Salary Ordinance shall remain in effect until changed by subsequent County Board Ordinance; and

WHEREAS, On May 17, 1994, the Ramsey County Board of Commissioners reaffirmed its approval of the terms and conditions of the current Salary Ordinance, and did not seek or receive a salary increase for calendar year 1995 over the annual salary rates for calendar years 1991, 1992, 1993, and 1994; and

WHEREAS, The Ramsey County Board of Commissioners again seeks no salary increase for calendar year 1996 over the annual salary rates for calendar years 1991, 1992, 1993, 1994 and 1995; Now Therefore Be It


- (a) Annual salary rate of \$40,996 for County Board members;
